

# **FEDERAL LAW**

- IDEA Individuals with Disabilities Education Act
  - Enacted in 1975, previously Education for All Handicapped Children Act
  - Provides equal access to a free public education regardless of disability
  - Ensured due process rights for students with disabilities
  - Requires children to be educated in the Least Restrictive Environment (LRE)
  - Set forth the provision of a Free Appropriate Public Education (FAPE)
  - Outlines requirements of an Individualized Education Program (IEP)
    - Related Services\*

# **FEDERAL LAW**

- ADA Americans with Disabilities Act
  - Section 504 applicable to entities receiving federal funds
  - Prevents discrimination in activities and programs on the basis of disability
  - Provides for accommodations/modifications and related services\*
- ESSA Every Student Succeeds Act (formerly No Child Left Behind)
  - Increased accountability for student with disabilities
  - Required teachers to be highly qualified in content areas

# **DEFINITIONS**

- Least Restrictive Environment LRE
  - Educating students with disabilities to the maximum extent possible with non-disabled peers; removing a child from the regular education environment should only result when the severity of the disability is such that educating the child despite services cannot be achieved satisfactorily
- Free Appropriate Public Education FAPE
  - Special education and related services that are provided at public expense to provide meaningful educational benefit
- Related Services
  - Services to be provided through the IEP (or 504) to facilitate the provision of FAPE
  - Speech Language Therapy, Occupational Therapy, Physical Therapy, etc.
  - Transportation

Based on individual needs, students receive accommodations and modifications in the general education classroom to enable them to reach their full potential while maintaining the integrity of the curriculum.

Our goal should be to bring the services to the student in the general education classroom, not remove the child from the environment.

# **IMPAIRMENT DEFINED IN SECTION 504**

- Have a physical or mental impairment that substantially limits one or more life functions, OR
- Have a record of such impairment, OR
- Be regarded as having an impairment
- An "impairment" is...

  - Major life activities include... caring for one's self, performing manual tasks, walking, seeing, hearing, speaking, breathing, <u>learning</u>, and working.

# **HEARING OFFICER DECISION (N.PENN)**

- LRE applies to home school and classroom for "instruction" in a "classroom"
- Facts of case
  - 7<sup>th</sup> grader; seizure disorder; I:I nurse during day and bus rides
- Issue
  - Must District allow student to ride regular transportation instead of District offered specialized transportation?
- Decision
  - NPSD prevailed
  - Special transportation is least restrictive environment for student
  - LRE also applies to transportation

# **IMPACT OF DISABILITIES**

- Autism
  - Sensory issues
  - Language disorder
  - Self-Stimulatory behavior
  - Problem behavior
- Emotional disturbance
  - Externalizing behavior
  - Aggressive
  - Non-compliance

- Intellectual Disabilities
  - Delayed cognitive development
  - May have problem behaviors
- Other Health Impairment
  - Seizure Disorder
- Multiple Disabilities/Physical disabilities
  - Wheelchair access

# **EXCLUSION**

- Processes in place through IDEA to protect students with disabilities
- Cannot be "excluded" from school (i.e. more than 10 consecutive days OR 15 cumulative days)
- Exclusion from the bus can be exclusion from school
- May require alternate transportation during "suspension" from the bus

# IMPLICATIONS ON TRANSPORTATION

- More students with disabilities being educated in their home schools.
- Do we have to?
  - Most of the time, the answer is yes. Every circumstance is different.
- How do we support students on regular transportation?
  - Provision of assistant or nurse on the bus to accompany the child
  - Train bus drivers and assistants
    - Disabilities awareness
    - Behavior plans
    - What to report

# IMPLICATIONS ON TRANSPORTATION

- Cost
  - In North Penn, approximate cost to provide special transportation to one student per year \$16,000
  - In North Penn, approximate cost to provide an assistant to the same student on regular transportation \$8,000
